Scientific Area: Aerospace, Computer Science, Mechanical Engineering and similar areas

Admission Requirements: To be enrolled at an integrated master or a master.

Workplan: The grant will take place in the scope of the project SmartRetail. The goal is the implementation of computer vision and machine learning algorithms.

Legislation and Regulations: Statute of Scientific Research Fellow, approved by Law nr. 40/2004, of August 18, as worded by Decree-Law nr. 123/2019, of August 28; IST-ID Regulation for Research Fellowships, available on https://ist-id.pt/recursos-humanos/bolseiros/#documentos-relacionados.

Workplace: The work will be developed at Instituto de Sistemas e Robótica of Instituto Superior Técnico, under the scientific supervision of Doctor Manuel Marques and co-supervision of Professor João Paulo Costeira.

Duration: The research fellowship(s) will have the duration of 4 months. It's expected to begin in February 2025 and may be eventually renewed up to the maximum of 24 months, including the duration of the initial contract.

Monthly maintenance allowance: the amount of the monthly maintenance allowance is € 990,98€, being the payment method by Wire Transfer.

Selection methods: The selection methods will be the following: i) Curriculum evaluation, ii) Programming skills and iii) Robotics/Computer Vision experience with a respective weight of 40%/30%/30%. There may be a possible individual interview, eliminatory in nature, to be used only if the previous selection method is not enough for a decision.

Composition of the selection Jury: Professor João Paulo Costeira, João Pedro Gomes and Doctor Manuel Marques

Announcement/ notification of the results: The final evaluation results will be communicated to all applicants by email.

Deadlines and procedures of complaint and appeal. A complaint may be lodged from the final decision, or an appeal to the Executive Board of IST-ID, within 15 working days counted from the respective notification.

Application deadline and formalization: The call is open from February 5 until February 18, 2025.
